

If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

GENERAL INSTRUCTIONS:

Axcela kills slugs and snails by irreversibly destroying the mucus producing cells that are essential for movement. The all-weather bait formulation is highly palatable and resists rainfall

TIMING: Apply baits when crops are most vulnerable and when the pest is evident and active during mild damp weather but when rain is not imminent. For broadacre crops, start when rain is not imminent. For broadacre crops, start when rain / moisture triggers slug and snail activity in Autumn and before significant egg laying or at or immediately after drilling and emergence. For other crops, time the application to protect the sensitive growth stages. For seedlings, best results may be achieved by applying 5-10 days prior to planting. Where the attack is heavy, it may be necessary to repeat the application. Snails need to be active to come into contact with the bait.

APPLICATION: Use a well calibrated granule or bait spreader to ensure even coverage over the entire land area to be protected. Apply by ground or air or direct drill with seed for slug control. For smaller areas hand treating can be effective. Do NOT place in heaps. Clean up any spilled baits, including those from filling any application equipment.

Use higher rates where infestation levels are high or under heavy rainfall conditions.

Restraint

DO NOT apply to edible plant parts or to crops where baits may be collected with harvested commodities.

DO NOT heap baits. Clean up spilled baits immediately, including after filling applicator.

risk: Avoid sowing slug susceptible crops after leafy crops such as brassicas which can carry high populations, especially in wet seasons. Remove straw and other harvest remains or incorporate

them deeply into the soil. Plough or cultivate under dry soil and weather conditions. Prepare a fine seedbed with a firm tilth to minimise the ability of some species of slugs to burrow through the ground.
